

A RESOLUTION SIGNIFYING COUNCIL'S INTENT TO ENTER INTO AN AGREEMENT WITH RUMPKE OF OHIO, INC. FOR THE COLLECTION, TRANSPORTATION AND DELIVERY FOR DISPOSAL AND/OR PROCESSING OF RESIDENTIAL SOLID WASTE, RECYCLABLE MATERIALS AND YARD WASTE GENERATED WITHIN THE CITY OF REYNOLDSBURG, OHIO

**WHEREAS**, pursuant to Section 715.43 and 3707.43 of the Ohio Revised Code, the City of Reynoldsburg may establish such collection systems and Solid Waste facilities as may be necessary or appropriate to provide for the safe and sanitary management of Solid Waste, including Recyclable Materials and Yard Waste, generated within the City of Reynoldsburg; and

**WHEREAS**, the City of Reynoldsburg has determined that it may be in the best interests of its residents that the City arrange for the collection, transportation and delivery for disposal or processing of all Solid Waste, Recyclable Materials and Yard Waste generated at Residential Units, Municipal Facilities, and during Special Events located within the City of Reynoldsburg from a single Contractor on an exclusive basis ("Collection Services"); and

**WHEREAS**, The current Collection Services Agreement between the City of Reynoldsburg and Rumpke of Ohio will expire on December 31, 2014; and

**WHEREAS**, on April 16, 2014, and on April 23, 2014, the City, as part of a Joint Bid Process with several communities located within the jurisdiction of the Solid Waste Authority of Central Ohio (SWACO") (1014 Consortium'), invited through advertisement in The Daily Reporter qualified providers of the Collection Services to submit bids to provide such Collection Services on the terms and conditions contained in the Collection Agreement as included in the Bid Documents; and

**WHEREAS**, on May 20, 2014, the Contractor submitted a bid to become the sole provider of Collection Services for the benefit of the City and its Residents: and

**WHEREAS**, after the official opening of the bids on May 20, 2014 by the 2014 Consortium and consideration of all bids for Collection Services, the City determined that the selected Contractor is qualified to provide the Collection Services to the City; and

**NOW, THEREFORE. BE IT RESOLVED** by the Council of the City of Reynoldsburg, Counties of Franklin, Licking, and Fairfield. State of Ohio:


**SECTION 1:** That the City Council of Reynoldsburg, Ohio does hereby reject all other bids for the collection, transportation and delivery for disposal or processing of all Solid Waste, Recyclable Materials and Yard Waste; and

**SECTION 2:** That the City Council of Reynoldsburg, Ohio does intend to authorize the Mayor to enter into a Collection Services Agreement with Rumpke of Ohio, Inc., that is substantially in accordance with the agreement as included in the Bid Documents, for a term of three (3) years with the possibility of two (2) extension years at the bid price of \$15.53 per residential unit per month for the collection of Solid Waste, Recyclable Materials and Yard Waste, effective January 1, 2015; and


**SECTION 3:** That the City Council of Reynoldsburg, Ohio does intend to authorize the Mayor to enter into a Recycling Services Agreement with Rumpke of Ohio, Inc. that is substantially in accordance with the Recycling Services Agreement as included in the Bid Documents, for a term of three (3) years with the possibility of two (2) extension years at the bid price of \$0.00 per ton for the processing of Recyclable Materials, effective January 1, 2015; and

**SECTION 4:** That it is found and determined that all formal actions of the Council concerns and relating to the adoption of this Resolution were so adopted in an open meeting in compliance with all legal requirements including Ohio Revised Code § 121.22: and

**SECTION 5:** That this ordinance is deemed to be an emergency measure necessary for the financial needs of the city and further so contract preparation may begin; wherefore, upon adoption by Council this ordinance shall be in effect immediately upon signature by the Mayor.
