APPLICATION FOR SEWER SERVICE BUILDER'S LICENSE

To the City of Reynoldsburg:

The undersigned hereby makes application for a sewer service builder's license, authorizing him to make sewer service connections in the City of Reynoldsburg in any or all sewer mains being the property of said City whether said mains are within or without the City Corporation Limits.

Applicant agrees that he will perform all the work and use the materials in conformity to all rules and regulations now existing or which may be hereinafter enacted governing the installation of sewer service connections.

Applicant deposits herewith a certificate of personal liability and property damage insurance, minimum amount of personal liability of fifty thousand dollars (\$50,000) for each occurrence, aggregate of one hundred thousand dollars (\$100,000) and a minimum amount of property damage of fifty thousand dollars (\$50,000), and a bond in the sum of two thousand (\$2,000) conditioned that he will save the City of Reynoldsburg harmless from damages to any persons or property by reason of the installation of any sewer service connection, as is provided by the regulations of the Service Director of the City of Reynoldsburg.
