Mr. Deskins moved to recess for Executive Session. Mrs. Kelly seconded. With the roll called, members voted: Mr. Stake "Yea"; Mr. Deskins "Yea"; Mrs. Kelly "Yea"; Mr. Joseph "Yea"; Mr. Clemens "Yea"; Mr. Cotner "Yea"; Mrs. Shirey "Yea". Mr. Hills said Council would reconvene only to call the roll and adjourn. Motion passed; Council recessed at 7:38 p.m.
