

MINUTES REGULAR COUNCIL MEETING  
REYNOLDSBURG CITY COUNCIL  
June 8, 2009

President of Council William L. Hills called the meeting to order at 7:30 p.m.

Members of Council present: Mel Clemens, Barth R. Cotner, Ron Stake, Fred Deskins, Jr., Leslie Kelly, Doug Joseph. Councilwoman Donna Shirey was absent.

The Invocation was given by Mr. Cotner. Mr. Hills led the Pledge of Allegiance.

Minutes of the regular Council meeting held May 26, 2009 were approved without objection. Minutes of the special Council meeting held June 1, 2009 were approved without objection.

The agenda was approved.

Clerk read report from Clerk of Court: total monies collected from Courts held during May, 2009 - \$43,174; monies also collected during that period pursuant to Ordinance Numbers 146-94 and 104-02- - \$3,872 for the Computerization Needs Fund; and \$100 for the Enforcement and Education Fund.

Mr. Hills said he had a conversation with Mr. Haire, the Development Director, who was making some modifications, as recommended by outside counsel, and also by the City Attorney, and further discussion would be held in committee. RESOLUTION ADOPTING THE REVISED CAPITAL IMPROVEMENTS PROGRAM FOR THE CITY OF REYNOLDSBURG, OHIO FOR THE YEARS 2009 THROUGH 2013- -Clerk read resolution by title for the third reading. Mr. Stake moved to amend to the redraft date of 6-5-09; Mr. Clemens seconded. With the roll called, members voted: Mr. Clemens "Yea"; Mr. Cotner "Yea"; Mr. Stake "Yea"; Mr. Deskins "Yea"; Mrs. Kelly "Yea"; Mr. Joseph "Yea". Motion passed; resolution amended. Mr. Stake moved adoption. Mr. Cotner seconded. With the roll called, members voted: Mr. Clemens "Yea"; Mr. Cotner "Yea"; Mr. Stake "Yea"; Mr. Deskins "Yea"; Mrs. Kelly "Yea"; Mr. Joseph "Yea". Motion passed; Resolution No. 36-09 adopted.
